JVI announces historic sponsorship deal with Jols!

All members will benefit!

Dear club coaches and managers,

It is with great pleasure that Judo Victoria Incorporated announces a new sponsorship deal with Jols Martial Arts Supplies, which will benefit all clubs and members!

Over the last few months Judo Victoria Incorporated has achieved major developments on behalf of all its members. These actions include:

1. Defining a new strategic plan
2. Successfully applying for two separate government grants
3. Successfully negotiating a sponsorship deal with Jols martial arts supplies.

What this means to you is:

1. A more focussed and goal driven future for JVI and its members. Many initiatives are included in the strategic plan which will help improve the capacity of JVI and bring more (especially young) judoka to the sport. It is our hope that all clubs will benefit from seeing more people coming along to try judo.
2. Extra resources to achieve goals and work on building judo in Victoria. In line with the new strategic plan, two government grants have been awarded to JVI. One for organisational capacity building, and the other for future development programs including during school and after school initiatives. Both these grants are performance based as such the committee are compelled to follow through. Ultimately the hope is to build the sport of Judo in Victoria. The trend has already begun with a significant increase in member numbers within the last 12 months.
3. Extra benefits of being a member of Judo Victoria Incorporated. As part of the new sponsorship deal ALL members including new members and re-registering members will receive benefits by way of sports equipment. The new member packages are as follows:
 - a. **New members** to JVI will receive:
 - i. A new ADIDAS judogi from supplied by Jols

 - iii. A drink bottle
 - iv. A carry bag for their judogi
 - v. JVI and JFA registration
 - vi. Sports injury insurance cover (limited)

 - iv. A 20% discount voucher for Jols (one time use, valid for 12 months, valid for purchases at Jols only, not exchangeable for cash)
 - v. JVI and JFA registration

- vi. Sports injury insurance cover (limited)

There are also extra benefits for the club as follows:

- a. **For each New member** to JVI, their club will receive:
 - i. \$5 JOLs credit to be used for purchases only, at Jols (valid for 6 months).
- b. **Re-registering members** will receive:
 - i. A credit amount of 5% (valid for 6 months) of the amount spent by that member when they use their 20% discount voucher. (eg: member purchases goods to value of \$100. That member uses their voucher and PAYS balance of \$80. Club receives 5% of \$80 in the form of credit - \$4).

JVI will be sending leaflets to all clubs to explain the new membership benefits directly to all members. The information will also be available on the website. We believe this is a big step forward for Judo in Victoria and hope you all enjoy what is the first step to a new future for JVI.
